Old Business

Town Boundaries J. Lindholm reported that he has been able to identify the town boundaries and map the Mendon/Chittenden line with the assistance of the Rutland Regional Planning Commission. J. Lindholm recommended the Selectboard consider having the town boundaries surveyed.

South Ridge Maple Products The Selectboard reviewed a letter submitted by South Ridge Maple Products requesting to do temporary repairs to Old Turnpike Road on the north side of the last house. The Selectboard previously informed Mr. Patrick Dupuis that he must submit a detail plan of the improvements and intended future use of the road for the Selectboard to consider. Until a plan has been approved the Selectboard will not authorize repairs to the right of way.

Declared Disaster DR 4140 S. Tully reported that President Obama declared disaster DR4140 which included damage from flooding rains between June 25, 2013-July 11, 2013. Mendon experienced road washouts on July 7th and July 8th. S. Tully submitted the request for Public Assistance and ERAF Form to the State of Vermont and FEMA.
