Administrative Matters

The orders were reviewed. Motion by M. Smith to approve payroll for 8/4/25 for \$14,397.70 and orders for 8/11/25 for \$13,206.99. Motion seconded by S. Bridge. The Selectboard unanimously approved the motion.

Grant Paperwork M. Smith reported the grant paperwork for GA1066 for \$11,500, BC2383 for \$130,500, BR1342 for \$20,000 has been signed and submitted to the State for execution of the agreements.

Motion by M. Smith to approve the minutes for 7/28/25. Motion seconded by S. Bridge. The Selectboard unanimously approved the motion.

Announcements:

Text My Gov – Text My Gov allows you to sign up for the most up to date information from the Town of Mendon. M. Smith reported the town has received 450 sign-ups since it launched.

Fy26 Tax Rate – M. Smith announced the FY26 Tax Rate saw an increase this year because it was recently discovered the FY25 Tax Rate was set artificially low by 10% to meet expenses. There was a transition on the Selectboard and the Administrative Staff along with dealing with some pretty significant issues at the time. M. Smith stated that these are not excuses, but rather an explanation as to what has happened. The Town has not experienced a cash flow shortage despite the error and S. Tully and J. Bridge are working on procedures to make sure the error does not occur in the future.
